VACANCY IN THE OFFICE OF JUDGE OF THE ENVIRONMENT AND LAND COURT OF THE REPUBLIC OF KENYA

The Judicial Service Commission (JSC) is a Constitutional Commission established under **Article 171 of the Constitution of Kenya, 2010** to promote and facilitate the independence and accountability of the Judiciary and the efficient, effective, and transparent administration of justice.

Following the declaration of vacancies in the Office of **Judge of the High Court** vide **Gazette Notice No. 7320** dated **4th June 2025**, the JSC invites applications from qualified persons to fill the vacancies pursuant to **Article 172(1)(a)** and as read with **Article 166 (1)(b), (2) and (5), Section 30 of the Judicial Service Act and the First Schedule of the Judicial Service Act (No. 1 of 2011)**.

POSITION: JUDGE OF THE ENVIRONMENT AND LAND OF THE REPUBLIC OF KENYA

Number of Posts : **Ten (10) posts**

Terms of Office : Retirement at the age of seventy (70) years with the option for early retirement after attaining the age of sixty –five (65) years in accordance with Article 167(1) of the Constitution.

Remuneration and benefits:

Based on guidelines by the Salaries and Remuneration Commission of Kenya, **Gross Monthly Remuneration Package excluding benefits is Minimum of Kshs. Kshs. 750,000 and a Maximum of Kshs. 1,029,691**

Functions of the Judge of the Environment and Land Court:

A Judge of the Environment and Land Court shall serve in any Environment and Land Court station in Kenya. The functions and jurisdiction of the Court is provided for under Article 162(2)(b) of the Constitution as read with **Part III of the Environment and Land Court Act, Cap 80**, namely:

- (a) Original and appellate jurisdiction to hear and determine all disputes relating to environment and the use and occupation of, and title to, land;
- (b) Hear and determine disputes relating to:
 - environmental planning and protection, climate issues, land use planning, title, tenure, boundaries, rates, rents, valuations, mining, minerals and other natural resources;
 - compulsory acquisition of land;
 - land administration and management;
 - public, private and community land and contracts, choses in action or other instruments granting any enforceable interest in land; and
 - any other dispute relating to environment and land.
- (c) Hear and determine applications for redress of a denial, violation or infringement of, or threat to, rights or fundamental freedom relating to a clean and healthy environment under **Articles 42, 69 and 70 of the Constitution**.
- (d) Exercise appellate jurisdiction over the decisions of subordinate courts or local tribunals in respect of matters falling within the jurisdiction of the court.

Constitutional and Statutory Requirements for Appointment:

For appointment to the position of Judge of the High Court, the applicant must possess the following minimum qualifications set out in **Article 166 (2) (a), (b) and (c) of the Constitution as read with Section 7 of the Environment and Land Court Act**, namely:

1. Hold a law degree from a recognized university, or be an advocate of the High Court of Kenya, or possess an equivalent qualification in a Common-law jurisdiction;

2. (a) Have at least ten (10) years' experience as a superior court judge or a professionally qualified magistrate;

or

(b) Have at least ten (10) years' experience as a distinguished academic, or legal practitioner or such experience in other relevant legal field;

or

(c) Have held the qualifications specified in paragraphs 2 (a) and (b) above for a period amounting, in the aggregate, to ten (10) years; and

(d) Possess the experience required under paragraph 2 (a),(b) and (c) above as applicable, irrespective of whether that experience was gained in Kenya or in another Commonwealth Common-Law jurisdiction; and

3. Have a high moral character, integrity and impartiality (meet the requirements of Chapter Six of the Constitution on Leadership and Integrity).

Notes:

- i) Experience gained in Kenya or in another Commonwealth Country with a common law jurisdiction will be considered;*
- ii) Knowledge and experience in environmental and matters will be an added advantage.*

In addition, the applicants should demonstrate a high degree of professional competence, communication skills, fairness, good temperament, good judgment, wide breath of both legal and life experience and demonstrable commitment to public and community service.

The appointments shall be made in accordance with **Article 166 (1) (b) as read with Article 162 (2) (b) and (3) of the Constitution of Kenya, 2010** and **Section 30 and the First Schedule of the Judicial Service Act, No. 1 of 2011 and Section 7 of the Environment and Land Court Act.**

HOW TO APPLY:

Interested and qualified persons are requested to make their applications by:

 - (a) A letter of application.
 - (b) A detailed and updated curriculum vitae, to include background information such as community service, financial discipline, pro bono activity (if any), involvement as a party in litigation and involvement in political activity including financial contribution to political party parties (if any) and criminal record, professional engagement, three (3) professional references and two (2) character references who can verify and comment on the applicant's past and present employment;
 - (c) Names of three (3) professional references and two (2) character references who can verify and comment about the applicant's past and present employment or engagement; **(please provide updated contacts – email and phone);**
 - (d) Copies of Testimonials, National ID/ passport, professional certificates, and academic transcripts
 - (e) A copy of **Certificate of Admission to the Roll of Advocates**.
 - (f) Copy of a Clearance certificate from **Advocates Complaints Commission**.
 - (g) Current practicing certificate.
 - (h) Applicant's recent colored passport-size photograph
 - (i) **Five (5) sample writings** of any professional writings, including but not limited to judgments, advocacy submissions in courts, scholarly writings or any legal publications that the applicant has authored.
 - (j) Declaration of income and liabilities as at the time of making the application, using the prescribed forms. The Declaration of Income, Assets and Liabilities Form JSC 2b can be downloaded from the JSC website – www.jsc.go.ke – Careers.
 - (k) **Public officers** should attach copies of returns of declarations of income, asset and liabilities for the **last three declarations**. Those in

private practice should attach audited accounts and tax returns for the **last three (3) years.**

 - b) Higher Education Loans Board,
 - c) Law Society of Kenya,
 - d) Directorate of Criminal Investigations,
 - e) Advocates Complaints Commission,
 - f) Ethics and Anti-Corruption Commission and
 - g) A recognized Credit Reference Bureau.
- ii) Original testimonials, professional certificates, academic transcripts and certificate of admission to the roll of Advocates.

Applicants **MUST** take note that it is a criminal offence to provide false information and documents in the job application and the same will be verified by relevant bodies.

 - Directorate of Criminal Investigation,
 - Ethics and Anti-Corruption Commission,
 - a recognized Credit Reference Bureau, and
 - Certificate of Good Standing from Law Society of Kenya.
 - Clearance from relevant professional body.
4.
