The Commission invites applications from suitable candidates to fill the position of **Adhoc Member, Political Parties Disputes Tribunal- Advocate**

### *Job Requirements: Academic and Professional Qualifications:*

Pursuant to **Section 39A (1)(a) of the Political Parties Act, No.11 of 2011**, a person to be appointed as an Adhoc Member of the Political Parties Disputes Tribunal - **advocate** must possess the following qualifications.

- i. Hold a Bachelor of Laws degree from a recognized university.
- ii. Have a post-graduate Diploma in law from Kenya School of Law or from a recognized institution.
- iii. Have at least **seven (7) years** of post-admission experience.
- iv. Must not be a public officer or holds office in a political party.
- v. Qualification and experience in alternative dispute resolution will be an added advantage.
- vi. Meet the requirements of Chapter Six of the Constitution on leadership and integrity.

### **Job Core Competencies:**

- i. High degree of professional competence
- ii. Good oral & written communication skills
- iii. Good temperament
- iv. Good judgement in both legal and life experience
- v. Commitment to public and community service

### **Tenure of Office**

Under **Section 39A (2) of the Political Parties Act, No.11 of 2011**, the tenure of office for the Adhoc Members shall not exceed **one (1) year** and shall serve on **part-time** basis.

### **Remuneration:**

The Adhoc members shall be paid such emoluments or allowances at rates determined by the Judicial Service Commission in consultation with the Salaries and Remuneration Commission.

### **HOW TO APPLY**

Interested and qualified persons are requested to make their applications by filling out an **Online Application** for Employment Form available at the JSC jobs portal: **<https://jsc.go.ke/jobs-2/>**.

Applicants should upload soft copies of the following documents to the online application:

- (a) A letter of application.
- (b) A detailed and updated curriculum vitae, to include background information such as community service, financial discipline, pro bono activity (if any), involvement as a party in litigation and involvement in political activity including financial contribution to political parties (if any) and criminal record, professional engagement, three (3) professional references and two (2) character references who can verify and comment on the applicant's past and present employment;
- (c) Names of three (3) professional references and two (2) character references who can verify and comment about the applicant's past and present employment or engagement.

- (d) professional certificates, testimonials, and academic transcripts, Certificate of Admission to the roll of advocate (where applicable)
- (e) Applicant's recent colored passport-size photograph
- (f) **Five (5) sample** writings, including but not limited to judgments, advocacy submissions in courts, scholarly writings, or any legal publications that the applicant has authored.
- (g) The applications must reach the Commission **NOT LATER THAN 12<sup>TH</sup> JUNE 2026 AT 5.00 PM.**

1. Only shortlisted and successful candidates will be contacted.
2. Canvassing in any form will lead to automatic disqualification.
3. Successful candidates will be required to submit valid copies of clearance certificates from the following bodies: -
  - Kenya Revenue Authority,
  - Higher Education Loans Board,
  - Directorate of Criminal Investigation,
  - Ethics and Anti-Corruption Commission,
  - a recognized Credit Reference Bureau, and
  - Clearance from the relevant professional body.
